Dear Community Leader:

Williams owns and operates a natural gas transmission pipeline known as Transcontinental Gas Pipe Line Company, LLC (Transco), which transports natural gas from natural gas production areas to customers such as utility companies and power plants located throughout the northeastern and southeastern United States.

Over the past year, we've held numerous project briefings and public meetings to help educate local leaders and the public about the proposed Northeast supply Enhancement Project (Project). Many of your constituents may have received a letter or been in contact with Williams regarding the Project. This letter is intended to provide additional information about the project and its status.

Project Scope

The Project is being designed to add 400,000 dekatherms per day of additional natural gas transportation capacity and is targeted to be in service for the winter heating season of 2019.

The Project design has many components including:

- Approximately 10.17 mile, 42-inch loop (Mainline D) in Lancaster County, Pennsylvania
- Compressor Station 200, Chester County, Pennsylvania Add 21,902 HP by installing one electric motordriven compressor unit
- New Compressor Station 206, Somerset County, New Jersey A new 32,000 HP compressor station near Transco's mainline consisting of two Solar Mars 100 compressor units and gas cooling
- Approximately 3.43 mile, 26-inch loop of the existing Lower Bay Lateral from Station 207 downstream to the Morgan M&R, Middlesex County, New Jersey (onshore)
- Approximately 23.5 mile, 26-inch loop of the existing Lower Bay Lateral from the Morgan M&R in Middlesex County, New Jersey to the Rockaway Transfer Point, New York State waters (offshore)

The Regulatory Process

Transco filed an application for the proposed Project with the Federal Energy Regulatory Commission (FERC) on March 27, 2017. This federal proceeding is referenced as FERC Docket CP17-101. The company is requesting a schedule that would allow all proposed facilities to be placed into service in the second half of 2019. FERC issued its *Notice of Application* on April 6, 2017.

You may begin receiving some information from FERC about the Project. During its review of Transco's application for the proposed pipeline, FERC assesses potential impacts to private property, the environment and communities.
